More than 400 Attended TI Retiree Luncheon

More than 400 retirees, guests, volunteers, and exhibitors attended this year's TI Retiree Luncheon on November 3, at the Mesquite Convention Center. Ellen Barker, Vice President and Chief Information Officer for TI, was the featured speaker. In her presentation, "Celebrating TI Contributions to the Information Age", she highlighted the key TI innovations which have helped fuel the advance in information technology. For the future, she pointed out that 46% of TI revenues are now made up of automotive and industrial applications, and that over the next 10 to 20 years, these are expected to be the fastest growing markets for semiconductors. November CIT Recap: TIAA conducted two Community Involvement volunteer events in November. Our first event was with Readers 2 Leaders on November 15. Five TIAA volunteers joined forces with our Senior Source host, Louise Watkins, to work at the Readers 2 Leaders headquarters in West Dallas. Readers 2 Leaders is a literacy program that serves West Dallas students ages 5 through 12. Our volunteer tasks at the agency included logging new books into their lending data base and stuffing over 200 envelopes with their annual donation request letters to be mailed to their current donor list. Our second volunteer event on November 21 was with Good Samaritans of Garland, which serves the communities of Garland, Rowlett and Sachse. Nine TIAA volunteers met at the “Good Sam” headquarters in Garland. Our tasks for the day included stocking over 500 pounds of canned and packaged food onto the Good Sam’s storage racks and providing help welcoming and escorting about 200 needy clients who arrived to pick up food packs for their weekly meals. We were rewarded by numerous smiles and words of thanks from all those that we served. And, we felt we made a difference in the lives of all those Good Sam clients.

December 7, VNA – Meals on Wheels Gift Wrap – Wednesday, 9:00 am to 2:30 pm. From feeding seniors who are homebound and hungry, to helping a terminally ill patient and their family deal with
